**WHAT IS CONSIDERED A GROUP?** A group is any schools that have something in common. For example, if they are part of the same school district or run by the same RESC or have a common religious affiliation or are all private schools.

### TO DETERMINE THE # OF SCHOOLS TO BE REGISTERED, COUNT THE # OF PHYSICAL LOCATIONS

1. If a group has **3 schools** running the CIC program, then those are **3 schools**.
2. If 1 teacher is running a CIC program at **2 different schools**, then those are **2 schools**.
3. If **1 school** has an in-class program & also an after-school program with different students, then that is **1 school**.
4. If **1 magnet school** is running a CIC program with students from 5 different towns, then that is **1 school**.

**HOW CAN A GROUP QUALIFY FOR A REDUCED REGISTRATION FEE?** Each school in a group can be registered by an individual of that school, multiple schools within a group can be registered by the one individual, or a combination of individuals can register all participating schools within a group before December 31 and each school will be charged the reduced registration fee. Once the registration information has been entered, there will NOT be a payment due immediately. **The CIC system will wait until December 31 to calculate the correct discounted registration fee.** At that time, the invoice(s) will be emailed to the person who registered the school(s), with payment options of paying by check or credit card. (CIC uses PayPal's secure payment processing system and accepts most major credit cards.)

**WHAT HAPPENS IF A SCHOOL REGISTERS AFTER DECEMBER 31?** A school can still register after December 31, but they will have lost the opportunity of a Group Discount and the registration fee will be \$150. **Registration for all schools will end on January 15, 2018.**

**WHAT ELSE IS CHANGED BY GROUP REGISTRATION?** Nothing. Even though the schools may have registered all at one time, they are still all individually listed in the CIC program.

**HOW CAN I REDUCE MY SCHOOL'S REGISTRATION COST?** Simply get 2 more schools in your group to participate in the CIC and when they register before December 31, 2017, YOUR cost will go down.
